



300 STATE OF THE WATERSHEDS REPORTS DISTRIBUTED

2017 marked the release of our first-ever State of the Watersheds Report. The report highlighted watershed activities and state and federal grant programs frequently used to support on-the-ground natural resource management.

In partnership with the Montana DEQ, MWCC hosted a two-day training on watershed restoration planning. The program provided tools for comprehensive watershed planning.

MWCC continued to grow the number of Watershed News subscribers, while maintaining open and click through rates well-above industry averages. The Legislative Bulletin was a new resource provided by MWCC. The bulletin provided an overview of relevant natural resource legislation, and was provided so watershed groups could keep tabs on the quick-paced legislative session.
